- Trip activities included N.E. Plaza, Kindercare Music, Lunch trip to Sam Seltzers, Breakfast at IHOP, Disston Plaza, Wal-Mart, Scottish Rite Trip, Pasadena Plaza, and Gateway Mall.
- On the Fourth of July, everyone wore red, white and blue. Residents attended an Indoor Picnic in the Dining Room, and in the afternoon, there was a special performance by Leslie and Sarah playing the cello and piano. They all enjoyed the Big Bucks Bingo which was held in the evening. Also that evening, some of the residents watched the fireworks outside by the Gazebo.
- Special events included a National Ice Cream Cone Day party, Root Beer Floats cart, July Berry Fest, a celebration of Helen Hula's 101st Birthday and Ben Watson's 99th Birthday in the Dining Room with the Blackwater Bluegrass Band provided by the visiting 18th Masonic District. The 18th District members also presented a generous donation of items for the Boutique and Corky's Cupboard to the Masonic Home! At the Monthly meeting of "What's on Your Mind?" with the Administrator, Lisa, the special guests where the Grand Master and First Lady, Dale and Rebba Goehrig.

LONG RANGE PLANNING & FACILITIES COMMITTEE REPORT: R:W: Lenny W. Lorenzo, Chairman

DIETARY DEPARTMENT: The total number of resident meals served for the month of July was 8,835 with 1,760 other meals, which included employees, visitors, and special events, for a total of 10,595 meals served. The Masonic Home collected \$657.50 towards meal cost. The raw food cost per meal was \$1.61.

SECURITY DEPARTMENT: There were no reportable incidents for the month of July. Five employee and five resident I.D. cards were issued.

HOUSEKEEPING/LAUNDRY DEPARTMENT: The Housekeeping Department standards are at a good level to maintain the facility standards. During the month of July the Housekeeping Department processed 43,440 lbs. of laundry. The total chemical cost was \$394.59.

GUEST HOUSE: The Guest House was occupied for 40 nights during the month of July. Visits were for the Board of Trustees and family members of several residents. The Masonic Home collected \$450.00 donations from Guest House occupants.

LONG RANGE PLANNING COMMITTEE REPORT:

1. Recommend acceptance of the bid for the Lawn and Landscaping Contract from Professional Grounds Management in the amount of \$41,700 subject to legal review of the contract. This results in an annual

- savings of \$28,766. We also recommend that our legal department send a letter to Ken Johnson canceling the existing contract.
- 2. Recommend that we obtain estimates for the lighting and electrical requirements for the hallway ceiling proposal.
- 3. Recommend that the bid in the amount of \$18,000 for removing the TECO Units from the roof be placed as a line item for the 2010-2011 Budget.
- 4. Recommend the acceptance of the bid for re-laminating the front reception countertop and supplying a small 2 drawer base cabinet for an amount not to exceed \$1,100 from Quality Kitchens subject to legal review of the contract.
